The Professional Guidelines Committee discourages arrangements in which the artist pays more than a 50% commission to the gallery on the retail price.

An art consignment agreement is a contract between an artist and gallery where the artist provides the gallery art at (typically) no cost and, in exchange, the gallery agrees to sell the art for a commission.
